#### Usman Khan – Non - Executive Member & PCC Chair

Usman Khan is a health policy and management professional with more than 25 years' experience. He is currently a Senior Advisor at the Good Governance Institute, a UK based consultancy and at FIPRA International, a Brussels based European public affairs consultancy.
